9 limit for fiscal year 2010-2011 for the City of San Bernardino.

10 **NOW THEREFORE**, BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE
11 CITY OF SAN BERNARDINO AS FOLLOWS:

12 **SECTION 1.** The action of the Mayor and Common Council in approving and
13 adopting Resolution No. 2010-221 is hereby ratified, and said Final Budget, as approved
14 and adopted, is the 2010-2011 Final Budget of the City of San Bernardino effective July
15 1, 2010.

16 **SECTION 2.** The City Manager is hereby directed to prepare budget
17 documentation and take such further action as necessary to implement the adoption of the
18 Final Budget, and to establish an appropriations limit in accordance with Article XIII B of
19 the Constitution of the State of California.

20 **SECTION 3.** This Resolution shall take effect upon the date of its adoption
