DUI Checkpoint Nets 10 Arrests

San Bernardino, CA – San Bernardino Police Department Traffic Unit conducted a DUI/Drivers License Checkpoint on 05-31-14, in the 400 block of S. Waterman Ave. in San Bernardino between the hours of 6:00 p.m. and 2:00 a.m. Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence and provide the greatest safety for officers and the public.

DUI/Drivers License checkpoints have been shown to lower DUI deaths and injuries. A major component of these checkpoints are the deterrent effects it has on those who might drive drunk or drugged impaired, bringing about more awareness and encouraging everyone to use sober designated drivers.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Ninety Percent of California drivers approve of checkpoints. The following stats are from last night's event:

- 647 Vehicles screened
- 6 DUI-alcohol suspects arrested
- 1 DUI-drug suspect arrested
- 1 DUI-combo drugs/alcohol
- 1 Suspect arrested public intoxication
- 1 suspect arrested for misdemeanor warrants
- 25 Drivers cited/arrested for operating a vehicle unlicensed or while suspended/revoked
- 28 Citations issued for other misc. traffic violations
- 24 Vehicles impounded
