Notice of Roadway Rehabilitation work along "E" Street
July, 2015

The City of San Bernardino and Omnitrans have collaborated on the planning and delivery of a construction project to repair and overlay "E" Street, from 300' north of 10th Street to Highland Avenue.

The planned work includes removal and replacement of deteriorated portions of the existing concrete cross gutters, curb, curb and gutter, driveway approaches and sidewalk; removal and replacement of existing water service laterals; construction of new curb access ramps where the existing ramps are substandard; construction of new concrete bus pads, and a new Asphalt cap on the pavement surface.

The work will also include construction of new bus lanes, extending the existing lanes from 10th Street to Highland Avenue. The new bus lanes will be located in the travel lanes adjacent to the curb and gutter (No. 2 lane), rather than in the middle of the street (No. 1 lane).

Match Corporation, a local contractor, has been hired to conduct the work. While the specific day-to-day work operations will be set by the contractor, general work phasing includes water line removal and replacement, concrete removal and replacement, bus lane construction, asphalt removal, and repaving.

The contractor will be responsible for handling traffic detouring during construction. The work will be phased to ensure that access is maintained to properties and businesses overnight, and as practicable, restored when construction operations are not occurring adjacent to any properties.

The project schedule includes the start of construction work by mid-July 2015, and planned completion of the work by the late Spring/ early Summer, 2016. Work will be phased during the construction contract, however, and will not occur within the entire project limits during the contract.

The contractor will provide a minimum of 48 hours of advance notice for the initial start of the work to all properties adjacent to the project. The City's field inspector will also be available during the construction work to provide more information on work operations after construction work begins.

The project will be constructed using federal funding provided through Omnitrans. Questions regarding bus route impacts should be directed to Omnitrans at (909) 379-7100.


